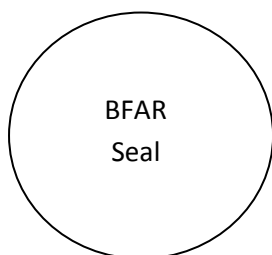

- a) The fish are processed in a form that is at minimum head-off, gilled and gutted.
- b) The final product comprising the consignment has been processed, packed and/or stored in a facility approved by and under the regulatory supervision of the Bureau of Fisheries and Aquatic Resources; and
- c) The facility specified above is subjected to regular inspection and audit to ensure that production, processing practices and quality control system and products comply with the following:
 - i. Final salmonid products for export to New Zealand have been processed from raw salmonid materials Imported exclusively from countries approved by New Zealand and are subject to effective separation Controls that ensure
 - the prevention of inadvertent or deliberate substitution, and
 - the prevention of commingling with, or contamination by, aquatic animal material originating in countries other than those approved.
 - ii. Consignment of raw materials that are split and sent to different processing plants are effectively tracked and clearly indicate;
 - the total number of parts the original consignment is split into,
 - the consecutive part number thereof, and
 - its respective percentage of the total original consignment.
 - iii. Movements of final salmonid products (intended for New Zealand) from processing premises to export facilities are effectively tracked; and
 - the final products comprising the consignment are derived from raw materials sourced exclusively from New Zealand, the European Union, Australia, Canada, the United States or Norway; and
